RESOLUTION #2010-2

WHEREAS, the Treasurer of Madison County, Nebraska has been granted authority to invest any surplus funds to secure the most beneficial rate of return to Madison County, and

WHEREAS, it appears to the County Board of Commissioners of Madison County, Nebraska, that it may be necessary for the Madison County Treasurer to deposit an amount in excess of 50% of the paid up capital and surplus of the Madison County banks designated as depositories for the county funds, and

WHEREAS, it would be in the best interest of the County of Madison to make available to said County all the facilities and services of said depositories, and

WHEREAS, the County Treasurer may deposit in said depositories amounts in excess of 50% when (1) the depository bank secures said deposits by a pledge of the assets of the bank in the manner and within the limitations provided for County Judges, Clerks of County Courts, and Clerks of the District Court in Sections 77-2326.04 to 77-2326.09 of the Revised Statutes of the State of Nebraska and (2) the same is approved by a formal resolution of the County Board,

NOW THEREFORE BE IT RESOLVED, that the County Treasurer of Madison County, is authorized and empowered to invest any surplus funds in the custody of the office of the County Treasurer of Madison County, Nebraska, and such funds shall be invested in order to assure the most beneficial safe rate of return to Madison County, and

BE IT RESOLVED, that the County Treasurer of Madison County, Nebraska be and she hereby is authorized to deposit and invest in the duly and legally designated depositories within and for said County of Madison any surplus funds, provided depositories secure said deposits by a pledge of the assets of the bank in a manner and within the limitations provided in Section 77-2318.01 and Section 77-2326 through 77-2326.09 of the Revised Statutes of the State of Nebraska.

Vicki Hrabanek, representing The Norfolk Daily News, was in attendance for designation of the official county newspaper for 2010. She requested the opportunity for The Norfolk Daily News to continue as the county newspaper.

Motion was made by Uhlir and seconded by Klein to designate The Norfolk Daily News as the official county newspaper for publication of the Commissioners' Proceedings from February 1, 2010 through January 31, 2011. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Motion made by Uhlir and seconded by Klein to approve the designation of the foregoing banks as depositories for Madison County funds for 2010. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

County Attorney Joseph Smith was present to discuss a bill received from Bryan LGH Medical Center for emergency protective custody services. He explained that Region 4 Behavioral Health System has contracts with Faith Regional Health Services and Richard Young in Kearney to provide emergency protective custody services; however, if patients are transported to other non-contracted facilities, Region 4 will not pay for the services rendered. Chairman McCallum reported that the patient was transported by the Norfolk Police Department to Bryan LGH Medical Center when a bed was available at Richard Young in Kearney. He explained that the Norfolk Police Department did not contact Region 4 Behavioral Health System to assist with locating a bed at a contracted facility.

County Attorney Joseph Smith explained that the County Board has the following options:

- 1) Request Region 4 Behavioral Health System to pay the contracted rate to Bryan LGH and request the Norfolk Police Department to pay the balance;
- 2) Approve full payment of the emergency protective services by the county; or
- 3) Request Norfolk Police Department to pay the entire bill.

After discussion, it was moved by Uhlir and seconded by Klein to table a claim payable to Bryan LGH, in the amount of \$7,482.67, for emergency protective custody services. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

County Assessor Jeff Hackerott, County Treasurer Donna Primrose, and Register of Deeds Nancy Gross were present for discussion on the county officials' salaries for the next elective term of office.

Commissioner Klein proposed that the salaries for the County Board would increase \$1,000 from 2010 to 2011, with a \$1,000 cost-of-living increase for the other three years of the elective term of office. He also proposed that the salaries for all other elected officials, except the County Surveyor, would increase \$1,500 from 2010 to 2011, with a \$1,500 cost-of-living increase for the other three years of the elective term. In addition, he proposed that the County Surveyor's salary would increase from \$10,560 annually to \$11,000 for 2011, with no cost-of-living increase during the elective term of office. Commissioner Klein also proposed that if the County Sheriff serves as the Jail Administrator additional compensation of \$5,000 would be paid annually, if the County Assessor serves as the County Appraiser additional compensation of \$5,000 would be paid annually, and if the County Clerk serves as Election Commissioner additional compensation of \$5,000 would be paid annually.

No comments were received from the elected officials in attendance.

The following resolution was introduced:

RESOLUTION #2010-4

WHEREAS, Section 23-1114 Nebraska Revised Statutes, requires the County Board to set the salaries of all elected

county officials for the following four year term of office prior to January 15 of the year in which a general election will be held for the respective county offices,

WHEREAS, 2010 is an election year in which elective county offices are to be filled pursuant to the election process by virtue of primary elections held in May of 2010 and general elections held in November of 2010, and

WHEREAS, the Madison County Board of Commissioners has carefully considered and analyzed the responsibilities and duties of the various elective offices, the Nebraska Association of County Officials' salary study, and salaries of comparable positions in other governmental sectors,

NOW, THEREFORE BE IT RESOLVED that the Madison County Board of Commissioners hereby establishes the following salaries for the various offices for the elective term beginning January, 2011:

BE IT FURTHER RESOLVED that the salary of the Chairman of the County Board shall be fixed at \$150.00 per month above the other County Board members' salaries, and

BE IT FURTHER RESOLVED that, if the County Sheriff also serves as County Jail Administrator, additional compensation in the amount of \$5,000.00 shall be paid annually for each of the calendar years of 2011, 2012, 2013, and 2014, and

BE IT FURTHER RESOLVED that, if the County Assessor also serves as County Appraiser, additional compensation in the amount of \$5,000.00 shall be paid annually for each of the calendar years of 2011, 2012, 2013, and 2014, and

BE IT FURTHER RESOLVED that, if the County Clerk also serves as County Election Commissioner, additional compensation in the amount of \$5,000 shall be paid annually for each of the calendar years of 2011, 2012, 2012, and 2013, and

BE IT FURTHER RESOLVED that, if the County Board of Commissioners designates any elected county official who is qualified to serve as a member of the budget committee, he or she shall receive additional annual compensation in the amount of \$1,500 for each of the calendar years of 2011, 2012, 2013, and 2014, and

BE IT FURTHER RESOLVED that the Board of Commissioners shall be given annual cost-of living increases in the amount of \$1,000 for each of the calendar years of 2012, 2013, and 2014 which shall be added to the previous year's salary, and

BE IT FURTHER RESOLVED that officials in each of the above offices, except the Board of Commissioners and County Surveyor, shall be given annual cost-of-living increases in the amount of \$1,500.00 for each of the calendar years of 2012, 2013, and 2014 which shall be added to the previous year's salary; and

BE IT FURTHER RESOLVED that, in addition to the above stated salary and cost of living adjustments, each elected official shall be enrolled in and receive the benefits of the County Employees' Retirement System as set forth by Section 23-2301 et seq. Nebraska Revised Statutes, and

BE IT FURTHER RESOLVED that, in addition to the above stated salary and cost of living adjustments, each elected official shall receive, during his or her term of office, the benefits of the same health and medical group insurance plan which is offered to all county employees, subject to the same terms, conditions, and contributions and subject to any modifications of such plan made during the term of office.

Motion was made by Uhlir and seconded by Klein that the foregoing resolution be adopted. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.
