COMMISSIONERS PROCEEDINGS

Madison, Nebraska

March 30, 2010

The Board of County Commissioners of Madison County, Nebraska met in regular session at 9:30 A.M.

Advance notice of meeting was published in the Thursday, March 25, 2010 edition of The Norfolk Daily News. A copy of said notice was mailed to each Board member. An affidavit of acknowledgment of receipt of notice of meeting as published was executed. Chairman Jerry McCallum called the meeting to order and notified the public of the location of the information regarding the Open Meeting Act posted in the meeting room.

Present: Commissioners Jerry McCallum, Rick Uhlir, and Lee Klein, and County Clerk Nancy Scheer. Road District #2 foreman John Hrabanek was present from 9:35 A.M. to 10:10 A.M. Planning and Zoning Administrator John Johnson was present from 9:50 A.M. to 10:00 A.M.

Chairman Jerry McCallum read the following consent agenda items into the record:

- 1) Approval of minutes of the March 16, 2010 meeting
- 2) Appointment of Bill Hatterman to serve as a member of the Madison County Veterans' Service Committee to complete the unexpired term of LeRoy Warneke
- 3) Approval of Monte and Carol Barnes' Lot Split located in SE¼ SE¼ Section 28-23-1 (Revisions were made to the plat approved by the County Board on March 2, 2010 prior to filing the plat.)
- 4) Approval of Gerald L. Wolff Lot Split located in SE¼ SE¼ Section 23-23-1

Motion was made by Klein and seconded by Uhlir to approve the consent agenda. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Motion was made by Uhlir and seconded by Klein to approve the regular agenda. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Pursuant to published legal notice to bidders in the March 18, 2010 and March 25, 2010 editions of The Norfolk Daily News, sealed bids for furnishing one new or used track type mini-excavator for Road District #2 were received. Road District #2 Foreman John Hrabanek and four sales representatives were present during the bid opening. Bids submitted by the following companies were opened and read aloud:

The bids were reviewed by Road District #2 foreman John Hrabanek and Commissioner Uhlir. After review, Commissioner Uhlir recommended to accept the bid submitted by Murphy Tractor & Equipment Company because the John Deere mini-excavator has several options that are not available on the Bobcat model, including better boom options. Road District #2 foreman John Hrabanek questioned if the boom of the Bobcat mini-excavator will shift over to the left or right without turning the cab. Nebraska Harvester sales representative David Scarf explained that an off-set boom on a backhoe slides all the way to either the left side or right side and he questioned if this is what the county wanted. Road District #2 foreman John Hrabanek stated that they wanted an excavator that would allow the boom to be pulled over to one side for digging off the side and Nebraska Harvester sales representative David Scarf responded that the Bobcat excavator does not have that option.

After discussion, it was moved by Uhlir and seconded by Klein to accept the bid submitted by Murphy Tractor & Equipment Company for purchasing a 2009 Model 85D John Deere mini-excavator and enter into a five-year lease purchase option with monthly payments at an annual interest rate of 3.950% and authorize Chairman McCallum to execute the lease purchase documents. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

County Extension Office staff members presented the annual report to the County Board. Extension Educator Lee Sherry, Associate Program Educator Michelle Kroupa, 4-H Assistant Sarah Polacek, Healthy Communities Initiative Coordinator Brandy Boschult, and Extension Board members Terry Radenslaben, Evelyn Muegge, and Carol Andrews were in attendance. Also in attendance were Prudential Financial Services Associate Brian Biggerstaff, 4-H member Jaden Moore, Nancy Moore, and Delores Patocka.

Extension Educator Lee Sherry reported that 4-H member Jaden Moore received the Prudential Spirit of Community Silver Medallion Award and there is only one awarded in the State of Nebraska for Jaden's age group. Prudential Financial Services Associate Brian Biggerstaff reported that Jaden Moore is being honored for making hundreds of colorful pillow cases over the last two years for sick and abused children. He explained that initially Jaden Moore made pillow cases as part of a 4-H project, but she was so touched by the response that she decided to carry the project on her own and she made appeals for fabric and monetary donations in the newspaper, on the radio, through 4-H and hospital newsletter, and through a poster at the county fair. He reported that with the help of fellow 4-H members, she spent countless hours cutting fabric to size, pinning, sewing, and folding new pillow cases which she delivered to the hospital's pediatric ward and the Child Advocacy Center of Faith Regional Health Services for distribution to children in dire need of some cheer. Mr. Biggerstaff stated that Prudential, in partnership with the National Association of Secondary School Principals, is proud to sponsor the Prudential Spirit of Community Program as a way to honor young Americans like Jaden Moore who care about their world and actively look for ways to improve it. He explained that Jaden Moore was among 5,000 students nominated from each state and as a state honoree she will receive \$1,000 and an all expense paid trip in early May to Washington D.C. where she will join more than 100 other top honorees from across the country for several days of national recognition events. He reported that ten of these honorees will be names Americas top youth volunteers for 2010 at that time. Mr. Biggerstaff then presented the 2010 Prudential Spirit of Community Award to Jaden Moore. Jaden Moore reported that she started this project when the local 4-H Extension Office asked all the 4-H families to make a pillow case and then she was asked to present the pillow cases and she could not believe how much it meant to the children who received them. She reported that the children were so happy to get their own pillow case. She stated that the hospital has been very receptive to the project by making labels for the pillow cases. She thanked Prudential Financial Services for the great opportunity and she explained that this has been a great experience for her. She stated that she was also thankful to all the people who donated fabric for the project.

4-H Assistant Sarah Polacek introduced the Extension Office staff. Extension Educator Lee Sherry reported that the Extension Board consists of 9 members and she introduced Terry Radenslaben, Carol Andrews, and Evelyn Muegge. She stated that the 4-H Council has 14 volunteer members and that Dr. Twig Marston is the district director. She explained that the Extension Office partners with Madison County, the University of Nebraska in Lincoln, and the U.S. Department of Agriculture to provide reliable, research-based information on agriculture and natural resources, consumer and family economics, community and economic development, and 4-H and youth development. Lee Sherry stated that the Extension Office slogan is "Know How Know Now" and the goal is simply to help put knowledge to work. She reported that total grant funding in the amount of \$138,006 was received during the year, which included the JC Penney's Partnership Grant, National 4-H Council Science Day Award, Gear Tech Grant, Nutrition Backpack Grant, Drug and Alcohol Mini Grant, and Health Communities Initiative. She also reported that UNL estimates that for every dollar that the county spends for the extension budget, \$5.63 in other dollars comes back into the county in the form of salaries, grants, staff development, equipment matches, specialists involvement, and administrative involvement. She stated that the Extension Office budget of \$141,125 returns to the county \$794,533.75.

Extension Educator Lee Sherry reported that David Kwaw-Menash, Ag Educator, works with agricultural and natural resources programs. She stated that Mr. Kwaw-Menash conducts pesticide training, Master Gardeners training, chemigation training, and works with 4-H youth development.

Michelle Kroupa, Associate Program Educator, explained that she works with the Nutrition Education Program, which involves food stamp recipients, especially single parents and minority households. She explained that the program was implemented to help participants develop skills and learn behaviors leading to improved nutritional well-being and food resource management. She shared statistics for high school youth regarding physical activity and dairy consumption. She reported that the adult nutrition programs include Norfolk Alternatives for Success, Women's Empowering Life Line, Head Start, Parent Night at Schools, the CYFAR Backpack Program, and English Second Language classes. Ms. Kroupa reported that she had contact with over 2,032 youth through the Youth Nutrition Education program presented at Head Start, Madison Elementary, Northern Hills Elementary, Grant Elementary, Lincoln Elementary, Washington Elementary, Jefferson Elementary, Westside Elementary, and Norfolk Senior School. She reported that she made contact with over 200 seniors with nutrition education. In addition, she reported that the 2010 goal is to continue to focus on maintaining summer programs and reach parents of youth.

4-H Assistant Sarah Polacek explained that the 4-H program is designed to help youth develop and utilize positive character traits, positive decision-making, communication skills, citizenship, community service, and leadership. She reported that the participation in the 4-H school enrichment program increased 6.4% from 2008 to 2009 and that 3,709 youths were involved in the program in 2009. She reported that in 2009 there were 286 members in 18 traditional 4-H clubs, with 260 adult volunteers and 33 youth volunteers. In addition, she stated that 34 youth were involved in an Afterschool Program. Mrs. Polacek explained that the adults and youth leaders donated more than 4,395 hours of service valued at \$65,925. She reported that the Extension Office offered 15 workshops throughout the year including science engineering and technology camps to learn about the power of wind, robotics, soils, tire printing, metal tooling, leather craft, sewing, baking, quilting, fishing, and babysitting. She explained that the Extension Office also conducted a Quality Assurance workshop to make sure that the youth swine exhibitors are certified with pork quality assurance. She reported that she coordinated and sponsored 40 youth on the Citizenship Washington Focus trip to New York, Philadelphia, and Washington D.C. where youth participated in civic workshops, committees, and field trips. She reported that the trip strengthened the participants' understanding of the importance of civic and social responsibilities. Mrs. Polacek reported that she was also involved in the School Enrichment programs which offer Life on the Farm programs including Embryology, Microbes, Robotics, GPS Day, Bullydance, Bread in a Bag, Talking with T.J., Project Learning Tree, Kids Growing with Grains, Character Counts, and Money Cents.

Lee Sherry reported that she focuses on 4-H science and technology programs. She explained that the Technology Camp offered information in computer applications, robotics, digital camera, and animation. She reported that the 4-H Robotics Club has three new leaders who are engineers from Nucor Steel. She also reported that 333 individuals participated in the GIS Day. She explained that a 4-H Scoop publication was started in 2009 with events that were happening daily for 4-H members during the county fair. Ms. Sherry reported that other 4-H programs offered were Character on the Job, Water Days, Wonderful World of Water, Duck Tape Purse, Babysitting Clinic, Speech Contest, Money Camp, Guardianship, YMCA Health Kids Day, Career Day at Wayne State College, and Career Exploration. She stated that 39 youth were involved in writing articles for the 35th 4-H Special Edition printed by in The Norfolk Daily News. She reported that 129 individuals were trained at a Child Care Conference and 89% of the participants stated that they would take one piece of information and implement it into their child care program.

Brandy Boschult, Healthy Communities Initiative Coordinator, reported that the Healthy Communities Initiative Project was formed out of a Partnership Grant between Elkhorn Logan Valley Public Health Department and the University of Nebraska-Lincoln to address alcohol misuse in the four counties of Madison, Stanton, Burt, and Cuming. She reported that the project is in the beginning stages of implementing strategies to reduce high-risk drinking. She explained that they are working on efforts to build community coalitions to address substance abuse issues. Ms. Boschult reported that they are partnering with the Nebraska State Patrol to conduct sobriety checkpoints and training beverage servers to refuse sales to underage or intoxicated persons. She stated that two Responsible Beverage Server trainings have been conducted with 21 alcohol servers being trained. In addition, she reported that the Healthy Communities Initiative hosted a town hall meeting in April 2009 with Nebraska's First Lady Sally Ganem who presented a documentary "Your Kids are Drinking" and in May 2010 another town hall meeting will be held with Dr. Tom Osborne discussing the responsibility of our community in addressing substance abuse issues among our youth.

Chairman McCallum commended the Extension Office staff members for their report and encouraged the staff to continue offering programs to the youth and adults in the county. The Board took no action.

Planning and Zoning Administrator John Johnson presented Richard Grant an Appointed Official's Award given by the Nebraska Planning and Zoning Association (NPAZ) and the Nebraska Chapter of the American Planning Association which was originally presented at the annual banquet on February 25, 2010. He explained that individuals nominated for this award are selected by the NPZA President.
