The Board of County Commissioners of Madison County, Nebraska met in regular session at 9:30 A.M.

Advance notice of meeting was published in the Thursday, May 20, 2010 edition of The Norfolk Daily News. A copy of said notice was mailed to each Board member. An affidavit of acknowledgment of receipt of notice of meeting as published was executed. Chairman Jerry McCallum called the meeting to order and notified the public of the location of the information regarding the Open Meeting Act posted in the meeting room.

Present: Commissioners Jerry McCallum, Rick Uhlir, and Lee Klein and County Clerk Nancy Scheer. County Highway Superintendent Richard Johnson joined the meeting at 9:52 A.M.

Chairman Jerry McCallum read the following consent agenda items into the record:

- 1) Approval of minutes of the May 11, 2010 meeting
- 2) Acknowledge receipt of the official bond of Greg Schindler as Clerk of Sanitary and Improvement District #5
- 3) Appointment of County Highway Superintendent as Authorized Representative for Disaster No. 1902
- 4) Authorization to advertise for bids for a motor grader for Road District #3
- 5) RESOLUTION #2010-23

WHEREAS, Stanton County has a full-time public employee on staff, who is fully qualified and has time and interest in serving as "Responsible Charge"; and

WHEREAS, Madison County has requested to enter into a Nebraska Local Public Agency Interlocal Cooperation Act Agreement with Stanton County for the services of a qualified "Responsible Charge" (RC) for a Federal-Aid project in Madison County; and

WHEREAS, Madison County and Stanton County have agreed on the terms and conditions of said Interlocal Cooperative Agreement as submitted.

NOW, THEREFORE, BE IT RESOLVED, by the Madison County Board of Commissioners that, Jerry McCallum, Chairman of the Board of Commissioners, is hereby authorized to sign on behalf of Madison County, the Receiving Local Public Agency (LPA), the Nebraska Local Public Agency Interlocal Cooperation Act Agreement for the following Federal-Aid projects in Madison County.

1. NDOR Project Number BRO-7059(15), NDOR Control Number 31749, Norfolk Southeast
2. A proposed project(s) legally described as: Beginning at the Southeast Corner of Section 31, Township 21 North, Range 3 West of the 6th P.M., Madison County, Nebraska; thence proceeding North 6 miles to Nebraska State Hwy. No. 32, being F.A.S. Route No. 2845
3. Any future proposed Federal-aid transportation improvement projects which receiving LPA may elect to do under this agreement

Motion was made by Klein and seconded by Uhlir to approve the consent agenda. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Motion was made by Klein and seconded by Uhlir to approve the regular agenda. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Pursuant to published legal notice in the May 13, 2010 and May 20, 2010 editions of The Norfolk Daily News, sealed bids for application of armor coat surfacing and aggregate sweeping of certain roads in Madison County for the 2010-2011 fiscal year were received. Bids submitted by the following companies were opened and read aloud:

After discussion, it was moved by Klein and seconded by Uhlir to award a contract to Sta-Bilt Construction Company for the application of armor coat surfacing and aggregate sweeping of county roads for the 2010-2011 fiscal year and authorize the Board Chairman to execute a contract with the company. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Pursuant to published legal notice to bidders in the May 13, 2010 and May 20, 2010 editions of The Norfolk Daily News, one sealed bid for striping certain roads in Madison County for the 2010-2011 fiscal year was received from Pogue Construction Inc. of Stromsburg, Nebraska.

After discussion, it was moved by Klein and seconded by Uhlir to award a contract to Pogue Construction, Inc. for striping county roads and authorize the Board Chairman to execute a contract with the company. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

County Clerk Nancy Scheer reported that the Blue Cross-Blue Shield health insurance rates for the 2010-2011 fiscal year would increase 8% from the prior contract year. She submitted a spreadsheet reflecting a cost comparison between the two contract years. In addition, she explained that \$345,000 was budgeted for the deductible buy-down costs for the 2009-2010 fiscal year and that the amount spent to date was \$132,790.22.

After discussion, a motion was made by Klein and seconded by Uhlir to renew the health insurance contract with NACO Blue Cross Blue Shield for the 2010-2011 fiscal year for the Blue Preferred (PPO) \$1,500 deductible plan, with the county to pay 100% of the premiums for full time employees for the single, 2/4 party plan, or family plan and the county to buy-down the deductible from \$1,500 to \$750. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.
