The Board of County Commissioners of Madison County, Nebraska met in regular session at 9:30 A.M.

Advance notice of meeting was published in the Thursday, September 10, 2009 edition of The Norfolk Daily News. A copy of said notice was mailed to each Board member. An affidavit of acknowledgment of receipt of notice of meeting as published was executed. Chairman McCallum called the meeting to order and notified the public of the location of the information regarding the Open Meeting Act posted in the meeting room.

Present: Commissioners Jerry McCallum, Rick Uhlir, and Lee Klein, and County Clerk Nancy Scheer. County Highway Superintendent Richard Johnson joined the meeting at 9:38 A.M.

Motion was made by Klein and seconded by Uhlir to remove the resolution to set the speed limit on Eisenhower Avenue between 25th Street and U.S. Highway 81 at 45 mph from the consent agenda so the matter could be discussed. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Chairman McCallum read the following consent agenda items into the record:

Motion was made by Klein and seconded by Uhlir to approve the consent agenda as amended. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Motion was made by Uhlir and seconded by Klein to approve the regular agenda as amended. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

The Board reviewed the following reports:

The Board discussed the proposed resolution to set the speed limit on Eisenhower Avenue between 25th Street and U.S. Hwy 81 at 45 mph. Commissioner Klein stated that he wanted the Board to conduct a public hearing on this proposal. County Highway Superintendent Richard Johnson reported that the state law does not require a public hearing when changing the speed limit and Commissioner Klein responded that he doesn't see any reason why the Board couldn't conduct a public hearing on this matter since it would provide an opportunity for individuals to comment on the matter.

After discussion, a motion was made by Klein and seconded by Uhlir to table the proposed resolution to set the speed limit on Eisenhower Avenue between 25th Street and U.S. Hwy 81 at 45 mph and set a public hearing on the matter for October 14, 2009. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Pursuant to published legal notice in the Thursday, September 10, 2009 edition of The Norfolk Daily News, Chairman McCallum opened a public hearing at 10:00 A.M. to receive citizens' comments regarding the proposed county budget for the 2009-2010 fiscal year.

One member of the media was in attendance during the hearing.

Budget committee members Nancy Scheer and Richard Johnson presented a summary of the proposed budget. They reported that the proposed budget is \$31,430,134, which will require \$9,827,328 in property taxes. They explained that the proposed budget represents an increase of \$3,121,355 from the prior fiscal year. Committee members explained that it was the desire of the Commissioners to have the levy rate near 40 cents and this was accomplished through the use of Inheritance Tax funds, spending cuts in General Fund, and reductions in anticipated cash reserves. They explained that taxpayers would see an increase of \$11.76 in property taxes for the county portion of taxes on a \$100,000 house. Budget committee members stated that complying with the Board's desire to set the levy at 40 cents resulted in \$467,578 of unused restricted fund authority that will be carried over to the next fiscal year.

No public comments were received during the hearing. Chairman McCallum closed the public hearing at 10:07 A.M.

After discussion, the following budget message was presented:

MADISON COUNTY, NEBRASKA BUDGET DOCUMENT
BUDGET MESSAGE

Pursuant to Section 13-501 through Section 13-515 Nebraska Revised Statutes (the Nebraska Budget Act), the Board of Commissioners herewith submits the budget for Madison County for the fiscal year July 1, 2009 through June 30, 2010. The total budget requirements of \$31,430,134 will necessitate \$9,827,328 being raised by taxation, and the balance of the total requirements, \$21,602,806 will be provided by county officers' fees, governmental subdivision aid, highway allocation, motor vehicle tax, proceeds from the sale of bonds, reimbursement from various local, state and federal sources, delinquent taxes, 2008 taxes now in the process of collection, and unexpended cash balance. \$246,315 of the property tax requirements will be used to pay principal and interest on bonds to finance major road construction projects.

The County budget is not intended to be a line item budget; however, the Madison County Board of Commissioners hereby requests and expects all county officials and department heads to contact the County Board if any expenditure will greatly exceed the amount budgeted for that purpose. The County Board of Commissioners will not approve any claims when the total budget for any office or department exceeds the amount budgeted, unless additional appropriations are approved in the manner prescribed by law.

The Board of Commissioners recognizes the need for rural fire protection and has allocated levy authority, as prescribed in Section 77-3443 Nebraska Revised Statutes, to all rural fire districts at the rate requested. Levy allocations were also authorized for the Norfolk Sanitary District and the Madison County Agricultural Society. The County Board will attempt to allocate levy authority to these entities in future budget years, but encourages exploration of other sources of revenue due to future uncertainties.

It has been the policy of the Madison County Board of Commissioners to hold the tax levy to a feasible minimum. Madison County has no registered warrants.

Motion was made by Klein and seconded by Uhlir that the foregoing budget message be adopted. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

The following resolution was introduced for consideration:

RESOLUTION OF ADOPTION AND APPROPRIATIONS #2009-55

WHEREAS, a proposed County Budget for the fiscal year July 1, 2009 to June 30, 2010 prepared by the budget making authority, was transmitted to the County Board on the 18th day of August, 2009, and

WHEREAS, a duly advertised public hearing on said budget was held as required by Nebraska Revised Statutes,

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Madison County, Nebraska as follows:

Section 1. That the budget for the fiscal year July 1, 2009 to June 30, 2010 as categorically evidenced by the budget document be, and the same is, hereby adopted as the budget for Madison County for said fiscal year.

Section 2. That the offices, departments, activities, and institutions herein named are hereby authorized, with County Board approval, to expend the amounts herein appropriated to them during the fiscal year beginning July 1, 2009 and ending June 30, 2010.

Section 3. That the income necessary to finance the appropriations made, and expenditures authorized, shall be provided out of the unencumbered cash balance in each fund, revenues other than taxation to be collected during the fiscal year in each fund, and property tax requirements for each fund.

Motion was made by Klein and seconded by Uhlir that the foregoing resolution be adopted. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Pursuant to published legal notice in the September 10, 2009 edition of The Norfolk Daily News, Chairman McCallum opened a public hearing at 10:00 A.M. to receive citizens' comments regarding adoption of the property tax for the 2009-2010 fiscal year at an amount different than the prior fiscal year. One member of the media was in attendance.

Budget committee members Richard Johnson and Nancy Scheer explained that the reason for the second public hearing is to comply with state law that requires an entity to conduct a special hearing when the property tax requirement is different than the previous fiscal year. They reported that the proposed property tax requirement of \$9,827,328 is an increase of \$693,574 from the \$9,133,754 property tax requirement in the previous fiscal year, which represents a 7.6% increase. They explained that the anticipated property tax would require a levy of \$.398975 per \$100 of assessed property valuation, compared to a tax levy of \$.387216 per \$100 of valuation during the prior fiscal year, with the difference being a 3% increase. Budget committee members reported that property taxes would be levied into the General Fund, Federal Aid Secondary Fund, and Road/Bridge Bond Fund. They stated that the portion of property taxes on a \$100,000 home, to fund the operations of county government for 2008 was \$387.22, and that the same homeowner will pay \$398.98 in property taxes for 2009, which is an increase of \$11.76, provided there was no increase in the valuation of the home. They also reported that of the total county property taxes, \$342.57 is levied into the General Fund to support general operations of county government, \$10.00 is levied for payment of bonded indebtedness, and \$46.41 is levied for major road and bridge projects.

No public comments were received during the hearing. Chairman McCallum closed the public hearing at 10:07 A.M.

After discussion, the following resolution was introduced:

RESOLUTION #2008-56

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the Madison County property tax request for the prior fiscal year shall be the property tax request for the current fiscal year for purposes of the levy set by the County Board of Equalization unless the Board of Commissioners adopts a resolution setting the tax request at a different amount, and

WHEREAS, the Board of Commissioners has completed the budget process and determined that the property tax required to fund the operations of Madison County for the current fiscal year is different than the property tax request for the prior fiscal year, and

WHEREAS, a public hearing was held to hear and consider comments concerning the property tax request,

NOW, THEREFORE BE IT RESOLVED, that the property tax requests and levies for the 2009-2010 fiscal year for the respective funds of Madison County be set as follows:

Motion was made by Klein and seconded by Uhlir that the foregoing resolution be adopted. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Joe Ferguson, representing the Norfolk Area Community Foundation, Dave Amick, Chairman of the Heroes Park Board, Norfolk Veterans' Home Administrator Jerry Eisenhauer, and Norfolk Veterans' Home Volunteer Service Coordinator Jenny Last were present to request funding for the Heroes Park project at the Norfolk Veterans' Home. Mr. Ferguson explained that the Heroes Park project is a fund under the Norfolk Area Community Foundation and this is the reason for his involvement.

Dave Amick stated that Madison County is honored to have the finest Veterans' Home facility in the State of Nebraska and also in this area of the United States. He stated that the facility is lacking any outdoor recreation area and the plan is to utilize the 8-acre area in the back of the Veterans' Home that is a large grassy field for Heroes Park. He explained that Heroes Park would be open for use by any veteran, not just veterans living in the Veterans' Home. A power point presentation regarding the proposed Heroes Park project was presented.

David Amick stated that the proposed Heroes Park is not a memorial wall, but is well planned and designed for veterans to promote outdoor activities. Jerry Eisenhauer reported that a great number of the members that are served in the Norfolk Veterans' Home are from Madison County although the facility serves the entire northeast Nebraska area. He stated that the Norfolk Veterans' Home has a direct impact on Madison County and that donations raised are a reflection of the pride in Madison County. He stated that they are coming before the Commissioners' to allow the Board an opportunity to be a part of the Heroes Park project. He stated that a donation by the county will stand as a legacy to the veterans and their families that the Commissioners feel that the project is important enough to donate funds for the Heroes Park. He stated that the project is planned for future generations and includes basketball courts and shuffleboard. He reported that he sees veterans with their family members pushing them outside in the parking lot trying to maneuver amongst traffic because there is no where else to go to enjoy the outdoors. He stated that Norfolk has a beautiful Veterans' Home and wonderful surroundings within the confines of the facility, but there simply isn't anywhere to go outside except the front porch.

Jenny Last reported that they are trying to do the Heroes Park project as locally as possible and by working with

Beckenbauer Construction. She reported that parking is a huge issue at the Veterans' Home and the plan is to put a new road around the proposed pavilion, which will incorporate 450 additional parking spaces. She explained that the veterans, their families, and service organizations would be able to use Heroes Park for many occasions including Memorial Day and Veterans' Day programs. She reported that Heroes Park would include a Flag Pavilion to honor the five services, a huge walking path, gardening areas, shuffleboard court, putt-putt golf, large picnic area, horseshoes, basketball court, and a children's play area. She explained that a windmill that is being donated for the Little Piece of Nebraska that also include native grasses. She reported that existing courtyards would be incorporated into the Heroes Park and waters ponds, game areas, more seating areas, and solitude gardens would be added. She reported that a solitude garden would be added by the hospice unit and would be very therapeutic for individuals who are near end of life.

Dave Amick stated that the Heroes Park would be a great area for veterans to spend time with their family members. He stated that they would appreciate an opportunity for the Commissioners to make a donation of \$100,000 from the county for the Heroes Park project. He reiterated that they are planning to use as many local people as possible to complete this project; however, the engraved gift bricks are being shipped from California because no local suppliers have them. He stated that he would like to use the contribution from Madison County as a lead gift for asking other counties to donate funds. Mr. Amick reported that Affiliated Foods is donating \$50,000 and, in addition, a campaign is being launched internally for all the employees of Affiliated Foods Midwest to donate to Heroes Park. He stated that Affiliated Foods plans to sponsor the flag pavilion. He also reported that Nucor, Vulcraft, and the Detailing Center are working together to provide the metal and design work for the pavilion area.

Chairman McCallum questioned if the donation could be made in increments over several years and Dave Amick responded that contributions could be made over a period of three to five years. Mr. Amick explained that they want to get adequate funding to build Heroes Park and at the same time they want to raise money for the Endowment Fund to provide for future care. He stated that although Heroes Park is being constructed on land owned by the Veterans' Home, 100% of the construction and maintenance costs will be paid with donated funds. He stated that Heroes Park will honor veterans and be very useful at the same time.

Jerry Eisenhower stated that he has worked in this industry for 28 years and when the Heroes Park project is completed, Norfolk will have the finest Veterans' facility in Nebraska.

Budget committee members Richard Johnson and Nancy Scheer explained that the Inheritance Tax Fund budget includes two payments of \$100,000 to the College of Nursing instead of one payment due to the large amount of collections received during the prior fiscal year. They reported that they considered making the \$100,000 payment due on November 1st and then analyzing the inheritance tax collections prior to fiscal year end to determine if another payment should be made at the end of June. They stated that the Board could approve a payment for the total amount of \$100,000 requested for the Heroes Park project.

After discussion, it was moved by Uhlir and seconded by Klein to donate \$100,000 from the Inheritance Tax Fund to the Norfolk Veterans' Home Foundation for the Heroes Park project to be paid in full from the 2009-2010 fiscal year budget. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

County Highway Superintendent Richard Johnson reported that he and Commissioner Uhlir plan to meet with representatives from the City of Norfolk, Stanton County, and Senator Mike Flood to discuss financing of the Nucor Road project. He requested that the Board recess into executive session to discuss negotiations for a potential contractual matter. Motion was made by Uhlir and seconded by Klein to recess into executive session to discuss contract negotiations. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried. The Board recessed into executive session at 11:05 A.M. with County Highway Superintendent Richard Johnson and County Clerk Nancy Scheer present.

Chairman McCallum recessed the meeting from executive session at 11:29 A.M.

After discussion, it was moved by Klein and seconded by Uhlir to direct County Highway Superintendent Richard Johnson and Commissioner Uhlir to commit up to one-third of the funding for Phase I of the Nucor Road project from Victory Road to Hwy 35, provided that Stanton County and the City of Norfolk each commit one-third of the funds. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

County Highway Superintendent Richard Johnson reported that Chairman McCallum received a letter from the Nebraska Department of Economic Development regarding recovery zone bonds and the Board of Commissioners must take action no later than October 15, 2009. He explained that there are two types of bonds, including recovery zone economic development bonds that are used to fund public infrastructure projects, and recovery zone facility bonds that can be used to finance private business activity. He explained that the Board must make a decision by October 15, 2009 to use or waive the use of the bonds allocated to the county.

Chairman McCallum questioned if there was any advantage to the county and County Highway Superintendent Richard Johnson responded that this depends if the 45% interest reimbursement by the federal government causes the total interest payment to be lower than a tax-exempt bond issue. Mr. Johnson explained that if the county chooses to not use the recovery zone bonds, the funds go into a pool for use by other entities. He reported that the county has the right to suballocate the bonds to any cities within the county. He recommended contacting all the cities within the county and the Economic Development District to determine if any entities or businesses desire to use any of the bonds allocated to the county.

After discussion, it was moved by Uhlir and seconded by Klein to direct the County Clerk to send notification to all the cities within the county and also the Economic Development District requesting if there is any interest in using recovery zone bonds allocated to the county. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.
